It hosted two exhibits in 2024: Creek of Hope, in partnership with Duwamish Alive Coalition and Delridge Neighborhoods development Association and Seattle's Forest: The West Duwamish Greenbelt in partnership with the West Duwamish Greenbelt Trails Group and Ridge 2 River Coalition/Duwamish Tribe. SWSHS welcomed 2,659 visitors in 2024.
